## RECOMMENDATION(S)

#### **BACKGROUND**

This report provides information on the activities of the Chief Administrative Officer (CAO).

### **DISCUSSION**

#### Administration:

The CAO continues to meet and work collaboratively with SCRD Volunteer Fire Departments on various issues both regional and individual service based. The next meeting is set for May 25, 2017.

The four CAOs from local government are scheduled to meet on Monday, June 12. The host of the meeting rotates and CAO Loveys is hosting this meeting. There are a number of joint initiatives to discuss as well as a welcome to the new District of Sechelt CAO.

Work continues with BC Timber Sales staff with respect to enhancing communication and engagement on the Sunshine Coast. Opportunities are being explored on how to work better with local communities. More information will be forthcoming.

On May 12 staff met with BC Water Authorization staff and Chapman Creek Hatchery staff to discuss the new legislation and creek flows. The meeting was productive and assisted in opening communications. Another meeting is scheduled for mid-June.

Staff have been assisting a number of local community associations with projects specific to their local communities. The assistance has varied and relies on what the community is looking to achieve. The SCRD Strategic Plan and Community Development Priority has been very helpful in aligning this work.

## SCRD Staff Development and Engagement:

- Leadership Forums continue once a month and have been very well received by the staff. Topics vary and cover a wide breadth of professional development opportunities such as work planning, budget and software applications, health and safety, team building and Roberts Rules of Order.
- The BEST training calendar continues to be popular with staff and most recently a number of staff participated in media training. The CAO is scheduled to provide more facilitation and public participation training in June.
