This Chief Administrative Officer's (CAO) report provides information to the Board on the recent activities of the Sunshine Coast Regional District.

DISCUSSION

Administration:

As we continue to operate under a Provincial state of emergency as a result of COVID 19, we are moving toward restarting some services at our Field Road office. Staff have been working on reopening the Field Road office on a limited basis and providing counter service in various departments. While we will be reopening on a limited basis, we recognize that the best way to keep the public and our staff as safe as possible is to limit exposure. Many of our staff will continue to work remotely and we will be developing scheduling that maximizes our ability to provide service while ensuring we are following all provincial guidelines and keeping everyone as safe as possible.

As we continue to evolve during these highly unusual times, we are implementing measures to ensure that we are able to enhance our responsiveness and service. I would like to extend my gratitude to the Senior Leadership Team, our managers and our staff for their continued efforts under challenging circumstances. I'd also like to acknowledge our IT department who continue to provide amazing support and constantly finding ways to improve our ability to work remotely.

Regional Collaboration and Partnerships:
