I'm following up with more information about your resolution EB16 that was pulled from the Endorse Block.

Williams Like passed a motion at Council to request that UBCM pull resolution EB16 – Medical Cannabis Safety Concerns from the Endorse Block. They did so in order to propose an amendment to include First Nations. The reasoning Williams Lake provided is as follows: *"Council has concerns that this resolution needs to be expanded, and that relevant health and safety requirements should apply across all jurisdictions (municipalities, regional districts and First Nations)."* 

#### **Original Wording:**

Whereas the federal *Cannabis Act* controls the production, distribution, sale and possession of cannabis in Canada, including the application and licensing of personal and commercial medical cannabis production, which should be compliant with local bylaws according to criteria set out for applicants in the process administered by Health Canada as the agency responsible for approval of cannabis production facilities;

And whereas local governments have responsibility for the enforcement of local bylaws and ensuring life-safety compliance with fire and building code regulations, but Health Canada has no process in place to share licensing information with local authorities about the location of medical cannabis production facilities in BC communities:

Therefore be it resolved that UBCM advocate for an expanded legislative framework that provides options for local authorities to oversee building and fire safety requirements for cannabis production facilities from the outset of the license application process and prior to the commencement of construction of cannabis production facilities in local communities;

And be it further resolved that UBCM advocate for federal and provincial collaboration with local governments to develop information sharing agreements, so local governments are informed of the locations and licensing particulars of personal and commercial medical cannabis production in their communities and can thereby ensure enforcement of local bylaws to mitigate safety risks within BC communities.

#### Proposed Amendment:

Whereas the federal *Cannabis Act* controls the production, distribution, sale and possession of cannabis in Canada, including the application and licensing of personal and commercial medical cannabis production, which should be compliant with local bylaws according to criteria set out

for applicants in the process administered by Health Canada as the agency responsible for approval of cannabis production facilities;

And whereas local governments **and First Nations (both self-governing and non-selfgoverning)** have responsibility for the enforcement of local bylaws and ensuring life-safety compliance with fire and building code regulations, but Health Canada has no process in place to share licensing information with local authorities about the location of medical cannabis production facilities in BC communities:

Therefore be it resolved that UBCM advocate for an expanded legislative framework that provides options for local authorities to oversee building and fire safety requirements for cannabis production facilities from the outset of the license application process and prior to the commencement of construction of cannabis production facilities in local **and First Nations** communities;

And be it further resolved that UBCM advocate for federal and provincial collaboration with local governments to develop information sharing agreements, so local governments are informed of the locations and licensing particulars of personal and commercial medical cannabis production in their communities and can thereby ensure enforcement of local bylaws to mitigate safety risks within BC communities.

As I mentioned in my earlier correspondence, EB16 will be referred to the UBCM Executive in November. I invite your community to share any comments regarding the proposed amendment. I will share your comments with the Executive as they consider EB16. Please send your comments to me **by November 18.**





I appreciate your concerns with respect to the level of police resources at the Sunshine Coast RCMP Detachment, in particular increasing calls for service with respect to mental health and workload pressures in the downtown area. In integrated municipal/ provincial RCMP detachments it is integral that police resources are commensurate to the workload demands of their respective areas.

As you know the provincial government is responsible for policing unincorporated areas and municipalities under 5,000 population. The Province is aware of the pressures facing front-line provincial police resources and in 2019 provided new additional funds to the BC RCMP to augment provincial resources at highest risk, greatest need provincial detachment units across the province. I am aware that the Sunshine Coast Provincial Unit was not identified by the RCMP as part of this process; however, let me assure you that the ministry continues to work with the RCMP, and internally to government, to address front-line, uniformed provincial police resourcing.

With respect to increasing authorized strength at provincial detachment units, the RCMP maintains internal processes through which local detachments may report pressures to BC RCMP Headquarters to identify and address. Local requests for increases are prioritized and considered in the context of the larger needs of the Provincial Service. I am advised that a business case for the Sunshine Coast Provincial Unit was not included in the RCMP's 2021/22 to 2025/26 time frame, however, I am confident that the RCMP will carefully consider any business case for additional resources as it moves forward through its processes. The RCMP also has the ability to recommend the re-allocation of existing provincial positions or funding new positions within its existing budget delegation. I can assure you that any recommendation brought forward by the RCMP to Government with respect to proposing changes to the organizational structure of the Provincial Police Service will be carefully considered by the provincial government.

For any resourcing pressures or increasing workload demands within the District of Sechelt municipal boundaries, the District has the ability to set local policing priorities, and directly control the level of police strength of the Sechelt Municipal Police Unit per the terms of its Municipal Police Unit Agreement. I encourage you to work with your Detachment Commander to ensure that police resources are accountable to the workload draws of the District of Sechelt to ensure policing is in alignment to municipal needs.

I value these important opportunities to exchange ideas and share information. Through continued collaboration, I am confident that we can work together to ensure the safety and security of the Sunshine Coast. All topics brought up in your meeting will be shared with the incoming Minister.

#### BYLAW NO. 687.3

A bylaw to amend Sunshine Coast Regional District Building Bylaw No. 687, 2014

The Board of Directors of the Sunshine Coast Regional District in open meeting assembled, enacts the following:

- 1. This bylaw may be cited as *Sunshine Coast Regional District Building Amendment Bylaw No. 687.3, 2020.*
- 2. Sunshine Coast Regional District Building Bylaw No. 687, 2015 is hereby amended as follows:
  - a) Add a new definition to section 1.2 as follows:

*Energy Step Code* means the system of energy performance requirements set out in Division B, Parts 9 and 10 of the Building Code.

b) Insert a new section 17 and renumber the remaining sections accordingly:

Part 17 – ENERGY STEP CODE

- 17.1 In relation to the conservation of energy and the reduction of greenhouses gas emissions, the Regional District incorporates by reference the British Columbia Energy Step Code in accordance with sections 17.2 and 17.3.
- 17.2 A building regulated by Part 3 of the Building Code and containing residential, business and personal services or mercantile occupancies, as defined in the Building Code, shall be designed and constructed to meet the minimum performance requirements specified in Step 1 of the Energy Step Code.
- 17.3 A building regulated by Part 9 of the Building Code and containing residential occupancies, as defined in the Building Code, shall be designed and constructed to meet the minimum performance requirements specified in Step 1 of the Energy Step Code.
- 3. This bylaw comes into force and effect on January 1, 2021.
