BACKGROUND

This Chief Administrative Officer's (CAO) report provides information to the Board on the recent activities of the Sunshine Coast Regional District.

DISCUSSION

Administration:

Board Remuneration

Weekly meetings continue and draft recommendations are being developed. On track to present findings at the January Corporate and Administrative Services Committee.

Bylaw Presentation - Next Steps

Bylaw staff met with the SCRD Board to discuss bylaw procedures. Staff have begun assembling information that will be provided into an upcoming committee report. This report will include the business licensing information.

Pre Budget

The budget process is now underway with the first Special CAS (pre-budget) taking place on November 5 & 6. We received an announcement regarding Federal/Provincial stimulus funding from Safe-Restart (COVID-19 Recovery Funds). Next steps will consist of community engagement and funding options/timelines.

Board Self -evaluation

The Board and CAO participated in a goal setting discussion related to the CAO performance review. The Board Evaluation discussion was held November 17 via zoom.

Manager, Strategic Initiatives Update

The Manager, Strategic Initiatives has accepted our offer and we are excited to welcome her aboard: It is a pleasure to announce that Mia Edbrooke has accepted our offer to join the SCRD in the newly created position of Manager, Strategic Initiatives.

General Manager, Community Services Update

The posting period has now closed and we have received several compelling applications. The interview process is currently underway.

CAO /Area A Not-For Profit Initiatives

The CAO and Director Lee met to discuss several Area A initiatives on November 2nd.

Green Bins:

This is week five of the Green Bin program. On average, over 10 tonnes of food waste is being collected per week. The SCRD Collects App has launched. With the App, residents can access their individual collection schedule or utilize a "what goes where" feature. The App can be accessed on the SCRD website or on a mobile device. Resident inquiries have reduced greatly and have shifted to operational questions.

qathet / SCRD Joint Meeting Nov 23

The Joint meeting with qathet Regional District and the Sunshine Coast Regional District Boards was held on November 23 via Zoom. Topics discussed were regional bus service, communication strategies for MOTI, BC Ferries, Regional Hospital District, marine debris recycling, barging garbage, economic development, tourism and COVID-19 communication from VCH.

Winter Intergovernmental Meeting – December 2nd

December 2nd date has been confirmed. Agenda is being developed. Platform will be via Zoom hosted by the Sunshine Coast Regional District.

shíshálh – BC Land Use Planning Engagement Workshop

Date confirmed for December 1 1:00pm – 3:30pm. Agenda has been developed by shíshálh staff.

SCRD/Sechelt/Gibsons/Construction Industry Roundtable

The Roundtable has been postponed due to provincial health orders. The roundtable participants (CAOs/Mayors/SCRD Chair / Representatives from Construction Community) will be contacted and the meeting rescheduled when in-person meetings are once again allowed.

MI TEL'NEXW Leadership Custom Workshop - Confirmed

The Mi tel'nexw Custom Leadership Transformation Workshop is a 2-day experiential training that educates on unlearning supremacy and learning new ways of being. This workshop is designed with an appreciative approach that responds to improving what we feel is lacking in "cultural competency" training and has been confirmed for Board and staff for December 8-9.
