- (3) A non-profit corporation or a public utility operated by an improvement district or local government may apply to the Regional District to reduce up to half of the applicable fee for a bylaw amendment application, development permit or development variance permit.
- (4) Public hearing advertisement costs may be waived if advertisement fees have been paid and more than one public hearing is required to correct a procedural and/or legal matter.

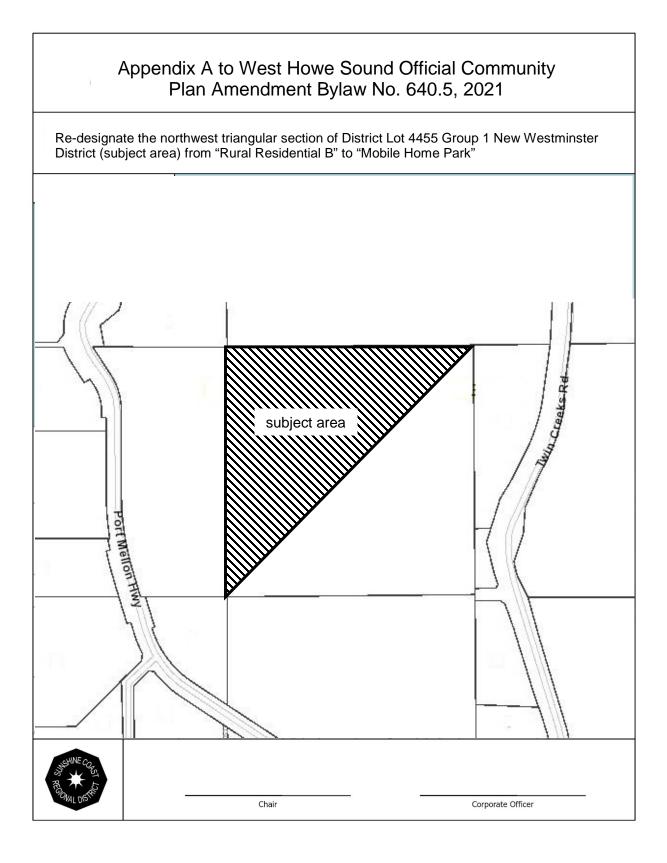

BYLAW NO. 722.1

A bylaw to amend the Sunshine Coast Regional District Zoning Bylaw No. 722, 2022

The Board of Directors of the Sunshine Coast Regional District, in open meeting assembled, enacts as follows:

PART A – CITATION

1. This bylaw may be cited as *Sunshine Coast Regional District Zoning Amendment Bylaw No.* 722.1, 2022.

PART B – AMENDMENT

2. Sunshine Coast Regional District Zoning Bylaw No. 722, 2022 is hereby amended as follows:

a. Amend *Schedule A* by rezoning the northwest triangular section of District Lot 4455 Group 1 New Westminster District from "RU2" to "RM3", and That part of District Lot 4454 lying to the east of the road shown on Reference Plan 4067 Group 1 New Westminster District from "RU2" to "C3", as depicted in Appendix A to this Bylaw.

b. Amend first row of "Conditions" in Section 7.6.3 as follows:

"In District Lot 4455 Group 1 New Westminster District, the number of mobile homes permitted shall not exceed 37."

c. Insert the following sub-section in Section 9.3.7:

"C) Notwithstanding Section 9.3.2, the following provisions shall apply to That part of District Lot 4454 lying to the east of the road shown on Reference Plan 4067 Group 1 New Westminster District:

1) Only the following uses shall be permitted:

- a) Campground with a maximum of 10 sites per hectare;
- b) Washroom and laundry facilities accessory to a campground;
- c) Restaurant and pub
- d) Convenience store and retail with a maximum floor area of 100 m²;
- e) Golf course and clubhouse;
- f) Billiard room;
- g) Gymnasium.

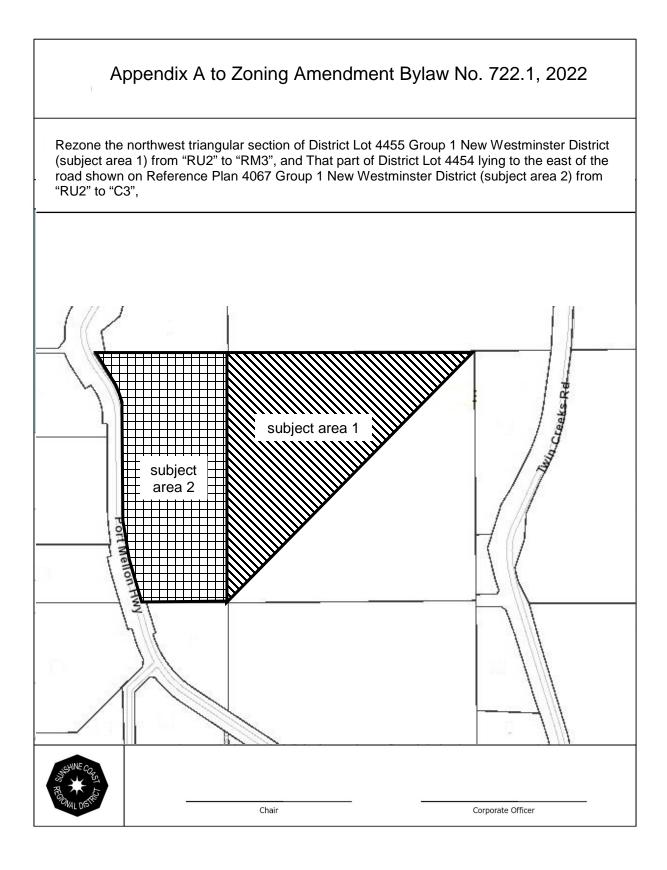
2) Notwithstanding Section 821.7, the parcel coverage of all buildings and structures except recreational vehicles or tents shall not exceed 20%."

SUBJECT: 2023 REVENUE ANTICIPATION BORROWING BYLAW

RECOMMENDATION(S)

THAT the report titled 2023 Revenue Anticipation Borrowing Bylaw be received for information;

AND THAT Sunshine Coast Regional District 2023 Revenue Anticipation Borrowing Bylaw No. 738, 2022 be given three readings and be adopted.

BACKGROUND

Under section 404 of the *Local Government Act* (Revenue anticipation borrowing), a Board may, by bylaw, provide for the borrowing of money that may be necessary to meet its current lawful expenditures before its revenue, from all sources, to pay for those expenditures has been received. Money borrowed for this purpose must be repaid when the anticipated revenue with respect to which the borrowing was authorized is received.

Property tax revenue is the main source of funding for operating expenditures incurred during the Financial Plan period which begins on January 1. As a result, short term borrowing is required from time to time to fund operating expenditures between January 1 and August 1, 2023.

The 2023 Pre-Budget Financial Plan anticipates revenue from property taxes in excess of \$27,000,000. These revenues are requisitioned from and collected by the Provincial Surveyor of Taxes and Member Municipalities and must be remitted to the Regional District on or before August 1st in each year. The purpose of this report is to secure cash flow funding for 2023 for the SCRD.

DISCUSSION

The Sunshine Coast Regional District has historically enacted a Revenue Anticipation Bylaw, annually, to provide for short-term borrowing to fund a portion of operating expenditures included in the financial plan until such time as tax requisition funds have been received.

The maximum amount that may be authorized by bylaw is 75% of all property taxes imposed in the preceding year. The 2022 Revenue Anticipation Bylaw authorized borrowing of up to \$15,000,000 which was deemed sufficient.

In 2022, \$7,953,921 of \$15,000,000 in revenue anticipation funding was drawn. Staff note that the current rates being offered on investments are high and exceed that of the current short-

term financing rate offered through the Municipal Finance Authority (MFA). Therefore, the use of investment funds is not recommended to supplement these costs.

The table below summarizes the borrowing as a percentage of the prior year's ad valorem taxation over the past three years as well as the proposed amount for 2023. The proposed borrowing amount for 2023 results in a borrowing percentage that is consistent with last 3 years.

Funds are borrowed through the MFA and are repaid as soon as possible after receipt of the tax revenue. Interest expenses incurred on short term borrowing are offset by revenue from the investment of tax requisition funds in the latter half of the year. These amounts are included in the annual financial plan under General Government.

Financial Implications

Short-term borrowing through the MFA incurs interest based on a floating daily rate. The current interest rate as of December 1 was 4.51%.

Actual interest expenses incurred is dependent on the amount and duration of borrowing as well as the interest rate in effect at the time. The interest expense is offset by income earned on the investment of tax requisition funds in the latter half of the year.

There are no fees to setup the loan and funds can be accessed as required on a non-reciprocal basis. Repayment can be made at any time without notice or penalty.

Timeline for next steps or estimated completion date

Subject to adoption of the Bylaw, a loan application will be submitted to the Municipal Finance Authority in the first quarter of 2023. Final approval of the loan is contingent on a loan agreement and promissory note being signed by the appropriate signing authorities.

CONCLUSION

Under section 404 of the *Local Government Act*, a Board may, by bylaw, provide for the borrowing of money that may be necessary to meet its current lawful expenditures before its revenue, from all sources, to pay for those expenditures.

Annual property tax revenue used to fund operating expenditures is not received until August 1st in each year. The Sunshine Coast Regional District has historically enacted a Revenue Anticipation Bylaw to provide for short term borrowing to fund a portion of operating expenditures incurred between January 1 and August 1.

Funds borrowed are required to be repaid upon receipt of the revenue in question. Interest expenses are offset by investment income earned on the investment of tax funds in the latter half of the year.

Staff recommend proceeding with the bylaw to authorize borrowing that may be necessary to meet current lawful expenditures.

BYLAW NO. 738

A bylaw to provide for the borrowing of money in anticipation of revenue

WHEREAS it may be necessary for the Sunshine Coast Regional District to borrow money from time to time to meet current lawful expenditures;

AND WHEREAS it is provided by Section 404 of the *Local Government Act* that the Regional Board may, without the assent of the electors or the approval of the Inspector of Municipalities, provide for the borrowing of such sums of money as may be necessary to meet the current lawful expenditures of the Regional District;

AND WHEREAS there are no liabilities outstanding under Section 404;

NOW THEREFORE the Board of the Sunshine Coast Regional District in open meeting assembled, enacts as follows:

- 1. This bylaw may be cited for all purposes as *Sunshine Coast Regional District 2023 Revenue Anticipation Borrowing Bylaw No. 738, 2022.*
- 2. The Regional Board shall be and is hereby empowered and authorized to borrow upon the credit of the Sunshine Coast Regional District an amount or amounts not exceeding the sum of FIFTEEN MILLION DOLLARS (\$15,000,000).
- 3. The form of obligation to be given as acknowledgement of the liability shall be a promissory note or notes bearing the Corporate Seal of the Regional District and signed by the Chair and the Chief Financial Officer.
- 4. All anticipated revenue of the current year or so much thereof as may be necessary shall, when collected, be used to repay the money so borrowed.
