SUBJECT: 2022 DROUGHT RESPONSE FINANCIAL UPDATE

### RECOMMENDATION

THAT the report titled 2022 Drought Response Financial Update be received for information.

### BACKGROUND

The Sunshine Coast Regional District (SCRD) activated an Emergency Operations Centre (EOC) on September 27, 2022, to ensure additional emergency planning could occur to secure water supply for 22,000 people on the Chapman Water System. The Emergency Operations Centre remains activated in support of the ongoing response efforts.

At the September 22, 2022 SCRD Board Meeting, the following motion was passed:

Edwards Lake Siphon Installation	It was moved and seconded
248/22	THAT the report titled Proposed Edwards Lake Siphon Installation be received for information;
	AND THAT the SCRD Board seek approval from the shíshálh Nation to proceed with the installation of the Edwards Lake siphon system;
	AND THAT the installation and decommissioning of a siphon system at Edwards Lake be approved in the amount of up to \$350,000 and funded through Regional Water operating reserves;
	AND THAT the SCRD Board request emergency water provision from the Town of Gibsons;
	AND THAT the SCRD Board and delegated authorities be authorized to enter into an agreement for 2022 emergency water supply with the Town of Gibsons;
	AND FURTHER THAT the 2022-2026 Financial Plan Bylaw be amended accordingly.

Subsequently, at the October 13, 2022 SCRD Board Meeting, the following motion was passed:

Drought Response Update	It was moved and seconded
266/22	THAT the report titled 2022 Drought Response Update and Financial Implications be received for information;
	AND THAT the 2022 Emergency Operations Centre (EOC) – Drought Response be approved for expenditures up to \$550,000 and funded through Regional Water [370] Operating Reserves;
	AND THAT the funds approved for the installation and decommissioning of the siphon system at Edwards Lake in the amount of up to \$350,000 be rolled into the 2022 Drought Response and associated funding (\$350,000 + \$200,000 = \$550,000 total);
	AND THAT staff work with Emergency Management BC on the potential reimbursement of some of the expenditures associated with the 2022 EOC – Drought Response Activation through the BC Disaster Financial Assistance program;
	AND FURTHER THAT the 2022-2026 Financial Plan be amended accordingly.

### CARRIED

The purpose of this report is to provide an update on response expenditures incurred to date, estimated future expenditures and commitments, and expected recoveries from Emergency Management BC.

### DISCUSSION

The Board has approved up to \$550,000 in incremental expenditures for function [370] Regional Water Service in support of the 2022 Emergency Operations Centre - Drought Response.

Incremental expenditures include all expenses incurred related to response activities with the exception of \$102,867 in regular wages and benefits for Utilities Services staff which are already accounted for in the Regional Water Service operating budget.

Although excluded from the expenditure limit, it is important to note that these wages are attributable to unplanned work that has diverted staff from regular operational activities and projects.

#### Summary of Expenditures and Commitments

The table below summarizes expenditures incurred to date, estimated future expenditures, and estimated recoveries from Emergency Management BC (EMBC) for key response activities undertaken to date:

Actual expenditures to date total \$233,740 while estimated future expenditures and commitments total \$262,620. The total estimated expenditures of \$496,360 is within the authorized limit of \$550,000.

Estimated future expenditures are based on estimates included in expense authorizations submitted to EMBC for response activities undertaken or underway. In most cases, these are conservative Class D estimates with adequate contingencies built in.

While the existing expenditure authorization is likely sufficient for these activities and the situation is currently stable, the Emergency Operations Centre remains active, and planning continues for further response activities should they be required.

Examples of such activities that could result in additional expenditures include the installation of a low-flow raw water pump at the Chapman Cheek Water Treatment Plant, the installation and use of a mobile water treatment unit at Gray Creek, and the mass supply and delivery of bottled water.

### Financial Implications

The Regional Water operating reserves had a balance of \$709,237 after accounting for the \$550,000 expenditure commitment approved by the Board on October 13, 2022. Only \$142,604 is expected to be required to fund current expenditures and commitments based on estimated recoveries for expenditures deemed eligible by EMBC.

### Timeline for Next Steps

Staff continue to work with EMBC and have initiated the claims recovery process for incremental wages and the Edwards Lake siphon installation. The claims process can be lengthy, and as such, recoveries will need to be estimated and accrued for fiscal year end at December 31, 2022.

A detailed update will be provided to Round 2 budget including a final summary of 2022 expenditures, status of claims, and any remaining authorized amounts that will need to be carried forward to 2023.
