WELCOME AND INTRODUCTIONS

Roundtable introductions of Ports Monitors (POMO) Committee members, Elected Official Liaisons, and SCRD staff members in attendance.

ACKNOWLEDGMENT

It was acknowledged that the Ports Monitors (POMO) Committee meeting was held within the traditional territory of the shíshálh and Skwxwú7mesh Nations.

AGENDA

The agenda was amended to add a reflection on the contribution and passing of POMO member Joseph Wright at the end of the Roundtable. The agenda was adopted as amended.

MEETING NOTES

The Ports Monitors (POMO) Committee Meeting Notes of May 29, 2023 were received and accepted as presented.

PORTS MONITORS COMMITTEE APPOINTMENTS UPDATE

The General Manager, Community Services provided a verbal update regarding the status of the Ports Monitors Committee representatives and appointments.

It was noted that there are three vacant positions on the POMO Committee: Halfmoon Bay dock, Vaucroft dock and West Bay dock. Recruitment is ongoing.

Staff will bring a report to the Board for re-appointment of John Richarson and Bruce Pollock to the POMO Committee for an additional two-year term prior to the end of the current term expiring March 2024.

PORTS DIVISION UPDATE

The Capital Projects Coordinator reviewed the staff report that was attached to the agenda package as Annex B.

KEATS LANDING

The Capital Projects Coordinator provided a verbal update on Keats Landing, which has been closed to vehicular traffic for safety reasons. Staff are working with an engineer to determine what repairs are necessary and will be presenting a report to the SCRD Board on the next steps (report anticipated prior to the end of Q1 2024).

POMO members expressed their desire to see the repairs addressed as soon as possible due to the challenges and inconveniences of not having vehicular access presents. Staff were also asked to get further clarity (if possible) on load capacity for the dock, and whether or not golf carts could be permitted. It was noted that the dock is very busy in the summer.

Leases

- Vaucroft Lease: Waiting for initial renewal paperwork from Province.
- Halfmoon Bay Lease: Current, expires 2027.
- Keats Landing Lease: Final lease package sent to Province for review.
- Eastbourne Lease: Current, expires 2027.
- Hopkins Landing Lease: Current, expires 2042.
- Gambier Harbour Lease: Current, expires 2027.
- West Bay Lease: Current, expires 2035.
- Port Graves Lease: Current, expires 2041.
- Halkett Bay Lease: In the final stages of approvals from the province.

Capital Projects (prior approved funding)

Keats Landing:

- An Engineer has been secured for the design work required.
- Scope of work has been defined to re-instate the vehicle load rating.
- A construction RFP will be posted as soon as the engineering design and specifications are completed. Estimated time of construction RFP posting is July.
- Construction will start after the award is approved by the Board (anticipated by end of Q3).
- Construction completion estimated for the end of 2024. Vehicle access will be opened pending engineering review and approval of work.
- This Keats Landing work is separate from the 4 capital projects listed below and will have its own separate timelines, RFP posting, engineer, and contractor.

Eastbourne, Gambier Harbour, West Bay, Halkett Bay:

- Project includes:
 - o Eastbourne:
 - Bents 3,4,5 upgrades/replacements of piles and footings.
 - 11 bents to receive upgrades/replacements of cross bracing.
 - New piles at bents 11 & 13.
 - Gambier Harbour:
 - Bents 2-7 upgrades/replacements of piles and footings.
 - 9 bents to receive upgrades/replacements of cross bracing.
 - New piles at bents 17.
 - West Bay:
 - New piles at bents 6, 9, 20.

- New float.
- Halkett Bay:
 - New piles at bents 3,4,6,9.
 - New bullrail at end of float
- 60% design package completed; 90% design package in final stages.
- Permitting and project scope package submitted to Fisheries and Oceans (DFO).
- Anticipate posting the construction RFP in July.
- Construction will start after the award is approved by the Board (anticipated by end of Q3).
- Construction timing for each dock TBD; estimated completion for all four by the end of Q4 or beginning of Q1 2025.

- Engineer has been retained and is working completing the design, using the information gained at the public engagement.
- An Open House was hosted on May 1, 2024. Thank you to everyone who attended and spread the word of this event! It was a great success. There was a large turnout, many great ideas, thoughts, and history were presented during this event. The information collected will be used to further the design and is a valuable guide to the engineer and the SCRD on how this facility is loved and used.
- The Engineer and the SCRD will be consolidating all the comments from the engagement process and will work towards a final design and updated cost estimate.
- Progress on this project will be provided on the Let's Talk page noted above.
- The Hopkins Landing work is separate from the other capital projects listed and will have its own separate timelines, RFP posting, engineer, and contractor.

Miscellaneous

- 1. Capital Asset Renewal Plan: Staff are currently working with the Asset Management team to develop a Capital Asset Renewal plan for all SCRD Ports. It is anticipated that this plan will be presented to the Board prior to the end of 2024.
- 2. Halkett Bay Port Currently working with the Squamish First Nation Rights & Title Office on entering a referral submission for the re-naming of the dock.
