



Home Composter Rebate Application

The Sunshine Coast Regional District (SCRD) is offering a rebate of up to \$100 per property to SCRD residents for home composters.

Note: This application is for composters purchased, installed and applied for in 2025. Composters purchased prior to 2025 are not eligible.

Applicants must:

- Be the residential property owner within SCRD Electoral Areas A, B, D, E, or F, including island residents or from either District of Sechelt, shíshálh Nation Government District or Town of Gibsons. Tenants should connect with property owner.
- Purchase and install the composter at the property listed on this application.
- Complete the Application Checklist in part 3 of this application.
- Submit a completed application form (including signature) with required documents.

If you qualify, a rebate cheque will be sent to the mailing address below. A complete list of eligibility and program requirements is available online at www.scrd.ca/composting.

Funding is distributed on a first come, first served basis. Completing this form does not guarantee receipt of a rebate.
