"Section 01 11 00 Summary of Work

Part 1:

1.1 General:

1.1.1 The Contractor will provide a Performance and Labour and Material Bond within 15 days of receipt of the written notice of award, will deliver to the Regional District a performance bond and a labour and material bond, utilizing one of the methods below:

1.1.1.1 The Performance and Labour and Material bonds will be each in the amount of 50% of the contract price, covering the performance of the work including the Contractor's obligations during the maintenance period. The bonds must be issued by a surety company that is licensed to carry on the business of suretyship in the province of British Columbia and in a form acceptable to the Regional District.

If the Contractor provides an e-bond the e-bond must be verifiable, containing a digital signature, digital corporate seal and a verification tag or a to check that the bond document has not been altered.

1.1.1.2 A bank draft, in the amount of 20% of the total contract price. The bank draft less 5% of the total contract price will be returned 60 days after the completion of the contract which will be held until the end of the maintenance period.

1.1.1.3 A letter of credit, in the amount of 20% of the total contract price, without a termination date. The letter of credit will be returned 60 days after the completion of the contract and after the issuance of a letter of credit for the warrantee period, without a termination date in the amount of 5% of the total contract price which will be held until the end of the maintenance period.

Item No.2 Closing Date and Time

The closing date and time has been changed from "September 26, 2024 at 3:00 pm local time" to "October 10, 2024 at 3:00 pm local time."
