

## SUNSHINE COAST REGIONAL DISTRICT

### BYLAW NO. 616

*Consolidated for convenience up to Bylaw 616.2*  
A bylaw to impose fees and other charges for use of the  
Dakota Ridge Recreation Area

---

WHEREAS the Sunshine Coast Regional District has established a service for the purpose of providing for the improvements, maintenance and operations of the Dakota Ridge Recreation Area as established by *Dakota Ridge Recreation Area Service Establishing Bylaw No. 1057, 2005*;

AND WHEREAS in accordance with Bylaw No. 1057, the Board may recover the annual cost of providing the service, by the imposition of fees and charges imposed under section 363 of the *Local Government Act*;

NOW THEREFORE the Board of the Sunshine Coast Regional District in open meeting assembled enacts as follows:

1. This bylaw may be cited for all purposes as *Dakota Ridge Fees and Charges Bylaw No. 616, 2008*.
2. In this bylaw the following definitions apply:

“Adult”	means an individual who is equal to or over the age 18 years and under the age of 60 years.
“Child”	means an individual who is under the age of 13 years.
“Day Pass”	means a pass or ticket purchased for the use of the Recreation Area and valid for a single calendar day
“Family”	means more than one and no more than 6 individuals, at least one and maximum two of whom is an Adult, who attend the Recreation Area together.
“GST”	means the goods and services tax payable under Part IX of the <i>Excise Tax Act (Canada)</i> .
“Recreation Area”	includes trails, warming hut, parking lot and washroom facility at Dakota Ridge
“Season Pass”	means a pass or ticket purchased for the use of the Recreation Area which is valid from the beginning of the ski / snowshoe season to the end (generally November through to May of the following calendar year).
“Senior”	means an individual who is equal to or over the age of 60 years.

“Youth” means an individual who is equal to or over the age of 13 years and under the age of 18 years.

3. Schedule A, attached hereto and forming part of this bylaw, are hereby adopted as the Fees and Charges for the Dakota Ridge Recreation Area.
4. The fees and charges set out in Schedule A are hereby imposed on persons using the Dakota Ridge Recreation Area and shall be paid in accordance with Schedule A.
5. Where there is an agreement for reciprocal discounts with other winter recreation facilities, fees will be discounted by 20 percent.
6. Fees for season passes purchased between October 1 and December 15 will be discounted by 10 percent.
