#### BYLAW NO. 626

A bylaw to impose fees and other charges for transit and related services.

WHEREAS the Sunshine Coast Regional District has established a service for the purpose of providing public transit through *Sunshine Coast Regional District Transit Service Establishing Bylaw No. 1073, 2007;* 

AND WHEREAS in accordance with Bylaw No. 1073, the Board may recover the annual cost of providing the service, by the imposition of fees and charges in accordance with the *Local Government Act;* 

NOW THEREFORE the Board of the Sunshine Coast Regional District in open meeting assembled enacts as follows:

- 1. This bylaw may be cited for all purposes as Transit Fees and Charges Bylaw No. 626, 2010.
- 2. In this bylaw the following definitions apply:

"Adult"	means an individual who is equal to or over the age 18 years and under the age of 65 years.	
"Child"	means an individual who is twelve (12) years of age or under.	
"Senior"	means an individual who is equal to or over the age of 65 years.	
"Student"	means an individual who is thirteen (13) years of age or older and is enrolled in an educational program up to grade 12.	

- 3. Schedule A, attached hereto and forming part of this bylaw, is hereby adopted as the Fees and Charges for the Transit Service.
- 4. The fees and charges set out in Schedule A are hereby imposed on persons using the Transit Service and shall be paid in accordance with Schedule A.
